Course Description

Students will read and discuss the Queen's Gambit book throughout the semester. We will also explore the details of the chess games and strategies that parallel the story in the book and the miniseries. To give students a fuller picture, we will study and play some in-class chess games and hold mini-tournaments throughout the semester. No expertise in chess is required other than knowing the basic rules of chess and wanting to learn more. At the end of the semester, students will present a final project of their choice that explores one of the themes of the book.

Course Objectives

Students will:

- Critically discuss the Queen's Gambit novel and compare it to the popular miniseries
- Improve their chess skills through study, puzzles, and game play
- Learn the basics of tournament chess, both online and over-the-board

Students will be evaluated on the following:

- Participation: in-class discussions and a minimum of one posting per week on the online forum.
- Two one-page essay on themes related to the book. Each essay should make a claim and include supporting material and background details. The one-page format requires conciseness and clarity.
- Chess puzzle: design an original chess puzzle at your skill level (usually mate or gain of material in a certain number of moves)
- Final presentation: Each student will give a 10-min presentation followed by up to 10 minutes of classroom discussion. Presentations will be held during the last 5 class meetings of the semester.

All assignments are due by the start of class on the due date. Late assignments lose 25% per day late.

In-Class Recording
