Course Description

How do you make the most of your time at UF and in the Honors Program? How do you decide what to do both while you're at UF and after graduation? This course for first-semester Honors students of all majors (including exploratory) will address these questions through readings, reflections, and discussions on the purpose of a university education as well as through skills-based workshops and assignments intended to produce deliverables with real-world application (resume, elevator speech, interview skills, etc.). The course is informal but heavily discussion based and will include several group presentations led by students.
