## **Course Description. Overview and Purpose**

Maps have played a central role in human societies since the beginning of time. As you will learn in this course, maps are not neutral representations of reality but powerful tools of communication. Maps exert an enormous amount of influence on a society's political structure, economic system, and imagination of the larger world. Maps are often used to highlight spatial data in informative ways or to help people get from work to the nearest bar. They are also used on a daily basis to track and kill people, to ostracize whole segments of society (i.e., redlining), and to forcefully rip apart ethnic groups. Using Mark Monmonier's How to Lie with Maps as our guide, we will be studying maps and analyzing their myriad roles in society. Through weekly discussions and a case study presentation, students will explore how maps work, what they are, who decides what goes on them, and how humans interpret them. We will learn how mapmaking has evolved, how the power to make maps has changed over time, and how digital technology is changing what can be done with maps. Finally, students will be introduced to the myriad ways that maps are used to shape society.

Class Attendance and Activities: Students significantly contribute to creating a comfortable and productive learning environment by attending and participating productively in class. *Reflection Journals*: Every few weeks, you will respond to questions that reinforce the read material. These assignments free response questions are intended to help you organize your thoughts and prepare for a fruitful discussion in class. These assignments are due on Tuesdays @ 11:59pm on weeks they are assigned.

*Case Study Presentation*: You will choose a map of personal interest and share it with the class, reflecting on the story it tells, its impacts, and its complications. These presentations will be given in the final weeks of class and should reflect the breadth of material we discuss in the preceding weeks.

Specific grading criteria for each assignment will be provided on Canvas. You are responsible for maintaining duplicate copies of all work submitted in this course until the end of the semester. In case of a grading dispute, you must notify the instructor via e-mail within one week of the date the grade is posted. It is your responsibility to ensure that all assignments are successfully uploaded to Canvas. Missing, corrupt, or incompatible files may result in grade penalties up to a score of zero for the assignment.

Late submissions will incur a penalty of 20% per day. A day is defined as 24 hours from the due date and time. Submissions more than three days late will receive a grade of zero.

I <u>highly</u> recommend starting work on assignments early to preclude unexpected emergencies or latesemester stress from compromising your grade. Deadline extensions may be available on certain assignments if requested ahead of time via e-mail, but must be justified. Canvas uses the "Display Name" as set in myUFL. The Display Name is what you want people to see in the UF Directory, such as "Ally" instead of "Allison." To update your display name, go to one.ufl.edu, click on the dropdown at the top right, and select "Directory Profile." Click "Edit" on the right of the name panel, uncheck "Use my legal name" under "Display Name," update how you wish your name to be displayed, and click "Submit" at the bottom. This change may take up to 24 hours to appear in Canvas. This does not change your legal name for official UF records.

# **Zoom Conference Privacy**

Should it become necessary or convenient to hold classes virtually using zoom, those class sessions may be audio-visually recorded for students in the class to refer back and for enrolled students who are unable to attend live. Students who participate with their camera engaged or utilize a profile image are agreeing to have their video or image recorded. If you are unwilling to consent to have your profile or video image recorded, be sure to keep your camera off and do not use a profile image. ## **In-Class Recording**

Students are allowed to record video or audio of class lectures. However, the purposes for which these recordings may be used are strictly controlled. The only allowable purposes are (1) for personal educational use, (2) in connection with a complaint to the university, or (3) as evidence in, or in preparation for, a criminal or civil proceeding. All other purposes are prohibited. Specifically, students may not publish recorded lectures without the written consent of the instructor. A "class lecture" is an educational presentation intended to inform or teach enrolled students about a particular subject, including any instructor-led discussions that form part of the presentation, and delivered by any instructor hired or appointed by the University, or by a guest instructor, as part of a University of Florida course.
