Course Description

Our book, "Photography Changes Everything," explores the many ways in which photographs package information and values, demand and hold attention, and shape our knowledge of and experience in the world. Students will read through this book together, having weekly discussions about various photographs and their corresponding essays.

Course Objectives

- 1. Read "Photography Changes Everything" and personally reflect on how photographs are used to prove a point, influence behavior, interpret human nature, or preserve a moment in time.
- 2. Engage in class discussion (speaking **and** listening), comparing and contrasting our individual responses to what we read.
- 3. Identify powerful photos and practice writing about their significance.

Plagiarism includes *unique expression*, which can be a phrase of a few words or a simple moniker. Our writing is mostly *our own expression*. When writing for science and business, we base our work on **facts** obtained from a variety of **credible sources**. We give credit where it is due. We **cite our sources** so

others can access the information we present. When appropriate, we very carefully, ethically, and lawfully use others' expression of that information. We obtain permission to use our sources' expression or give full credit for a *limited, fair use,* including direct quotes.

Recording Statement

Students are allowed to record video or audio of class lectures. However, the purposes for which these recordings may be used are strictly controlled. Publication without permission of the instructor is prohibited. To "publish" means to share, transmit, circulate, distribute, or provide access to a recording, regardless of format or medium, to another person (or persons), including but not limited to another

student within the same class section. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services.
