#### **COURSE DESCRIPTION**

Society and higher education are continually changing so there is always something new to learn by studying college life and college students. The sociology of education and higher education research fields are storied, producing much of what we know about the macro (e.g., organizations, processes) and micro (e.g., identity development, relationships) outcomes of attending, completing, and not completing college in the USA. What can be learned from studying high-achieving (i.e., honors) students at this snapshot in time? In this CURE course, students will assist instructor Dr. TehQuin Forbes with exploratory research related to student narratives, experiences, and outcomes at a large, public research university. There will be a technical focus on qualitative research methodology and a substantive focus on high-achieving (i.e., honors) students. This course is particularly of interest to high achieving students of all departments.

An IRB form has been developed in coordination with this course and submitted with the following project title: Qualitative Investigation of Honors Students' Attitudes and Narratives in the Mid-2020s

### **COURSE GOALS AND LEARNING OBJECTIVES**

This course's primary goals are for students to gain practical research skills and be introduced to sociology and education literatures. This course's secondary goal is to advance the present research agenda.

Upon completion of this course, students will have done all the following:

- Synthesized social science scholarship to prepare annotated bibliographies and literature reviews
- Assisted in creation of an in-depth interview guide, a vital data collection instrument
- Conducted and transcribed in-depth interviews
- Coded interview data and analyzed said data using qualitative data analysis software NVivo
- Practiced reporting research findings to a public audience, in both written and oral formats

#### **MATERIALS**

All required materials will be provided in the course Canvas website.

#### **ASSESSMENT**

A student's final grade in this course will be determined using the following:

Attendance and Participation – 25% Reflection Paper – 25% Research Deliverables – 50%
